Rules of Quarterly Business Coupon Program

1. All member organizations whose membership dues are paid in full for the current year as follows:
 - ~ 1st Quarter Coupons (1 Jan-31 Mar)-Dues paid by Dec 15th-Coupons posted NLT 1 Jan.
 - ~ 2nd Quarter Coupons (1 Apr-30 Jun)-Dues paid by Mar 15th-Coupons posted NLT 1 Apr.
 - ~ 3rd Quarter Coupons (1 Jul-30 Sep)- Dues paid by Jun 15th-Coupons posted NLT 1 Jul.
 - ~ 4th Quarter Coupons (1 Oct-31 Dec)-Dues paid by Sep 15-Coupons posted NLT 1 Oct.
2. Coupon Program with one coupon is voluntary and free for all paid members. Additional coupons during any quarter are \$50.00 each with a maximum of four (4) per year.
3. Coupons will have disclaimer and expiration date on last day of every quarter.
4. Organizations are eligible for a quarterly door prize (\$ 50.00 Chamber Bucks) and will receive one door prize registration for each USED coupon they return in to the CSACOC office by the last day of each quarter. (i.e. March 31, June 30, September 30, and 31 Dec 2010). All used coupons returned should have the month, day, and year coupon was used written on the back.
5. Once a quarterly coupon is posted, it will stay posted for the entire quarter. Changes in a coupon for the next quarter are also due prior to the last day of each quarter)
